2011 MATCHING GRANT PROGRAM



The downturn in the nation's economy put tremendous strains on local non-profit health care agencies, who experienced budget cuts while demands for services grew. We responded by continuing to offer challenge grants tied to organizational efforts to increase support from individuals.



T

he Health Foundation Challenge Grant recipients for 2011 were:

Ruby Pardue Blackburn Adult Day Health Care Center *\$15,000.00 challenge grant*

The center provides a safe place for adults of fragile health to spend the day under medical supervision. Clients include patients with developmental disabilities, Alzheimer's disease, and the effects of stroke, along with other mental or physical impairments. It is designed to be an affordable alternative to nursing home placement or assisted living.

Wilkes Adult Developmental Activity Program *\$15,000.00 challenge grant*

By teaching job skills to adults with disabilities, ADAP fosters the self-esteem and quality of life for its clients. Additionally, the program teaches self care skills, including exercise. Parents of its clientele also enjoy a respite from caregiving which aids in stress reduction and provides a sense of well-being.

Carenet Counseling of Wilkes

\$7,500.00 challenge grant

Formerly Pastoral Care and Counseling of Wilkes, this program provides outpatient counseling services to individuals, couples, and families dealing with emotional, social, spiritual, and mental health issues. It is designed to integrate mental, physical, spiritual and community health and serves people regardless of income.

Appalachian Senior Program

\$2,500.00 fundraising sponsorship

This program pairs older volunteers (age 60+) with children who have special emotional, social, or educational needs. Both parties benefit from their involvement in the program.

The Mobile Expanded School Health Bus

\$500 fundraising sponsorship with additional matching grant

Teenagers' health care needs are often overlooked, and so the MESH bus brings health care professionals to high school students. Students receive everything from immunizations and sports physicals to health assessments, physical exams, and mental health services.

Wilkes Sheltered Aid for Families in Emergencies

\$6,000.00 challenge grant

SAFE provides a comprehensive program of services to victims and survivors of domestic violence and sexual assault. They operate a shelter for families who are not safe in their own homes, as well as operate a crisis telephone line.

The Child Abuse Prevention Team

\$6,000.00 challenge grant

This program helps parents learn safe, healthy ways to discipline children while also providing a neutral environment for court-ordered supervised visitation.

ADDITIONAL GRANTS

The Wilkes Public Health Dental Clinic

\$5,000.00

Wilkes County boasts the highest percentage of people seeing a dentist in the state, a feat that translates into healthy, happy smiles for thousands of people. Low income and uninsured patients see their dentist on a sliding fee scale. The Health Foundation awarded the group additional funding to further expand its reach by hosting two free dental clinics.

Sexual Assault Nurse Examiner Training

\$2,049.00

This grant provided training to nurses who respond to victims of rape and sexual assault. Nurses are taught medical forensic evidence collection and how to best treat the victim.

Wilkes Regional Medical Center Education Department Equipment

\$1,477.00

Physicians and clinicians rely on the library within the hospital in order to research and stay current on health care issues.

Old Hickory Council, Boy Scouts of America

\$7,500.00

This special award helped build a Health Lodge at Camp Raven Knob, a popular destination for Wilkes

County Scouts. The lodge treats campers who have been injured or become ill.

Wilkes Regional Medical Center—other projects

\$7,349.72

A bilichek device that allows newborns to be checked for jaundice without having to endure a needle prick is one of an assortment of items provided.

Lunch and Learn

\$240.00

The Wilkes County Health Department and The Wilkes County Library collaborated to offer a series of health education topics. Local doctors and other health care professionals donated their time and expertise to educate participants.

Ensuring access to medical care is a key Foundation strategy

When Wilkes General Hospital first opened its doors, the emergency department consisted of two exam rooms. One of the rooms doubled as the morgue.

Patients used a telephone at the check-in desk to summon a nurse, who would then call a doctor in if need be.

Things have changed pretty dramatically since then.

Today Wilkes Regional Medical Center handles more than 32,000 patient visits per year, making it the busiest emergency department in the region. Board-certified emergency department physicians see patients round-the-clock. And no one is ever turned away regardless of their ability to pay—making it the health care safety net for the elderly, the poor, and the uninsured.

Increasing patient volumes created issues with being able to see people as quickly and efficiently as hospital

leadership would have liked. Crowded waiting rooms and an insufficient number of exam rooms also compromised patient privacy.

This led the hospital to embark on a major expansion of the emergency department, adding 9,500 square feet to the front entrance of the department. The original space will also be up-fitted to meet modern standards of care. The number of exam rooms when complete will raise to twenty-eight.

The Health Foundation was asked to help provide funding. By year-end of 2011, the hospital administration, staff, and board of directors were invited to participate in the campaign. Over \$215,000.00 was awarded to the hospital in the first year of a planned five-year effort.

Donors who make gifts of over \$1,000 will be recognized on a plaque inside the new emergency department. Naming opportunities for larger gifts are also available.

2011 SCHOLARSHIP RECIPIENTS

Brad Shinaman, chair of the Scholarship Committee since its inception, considers the chance to meet candidates one of the most rewarding aspects of his board service. A practicing dentist in North Wilkesboro, he has had years of experience calming nervous patients—a skill he puts to use in helping scholarship candidates feel at ease. Many of the students plan to juggle work and school in order to pay for their educations. Others find the demands of family obligations, class time, and clinicals make it nearly impossible to work. Regardless, the scholarships represent a way to make it a little more manageable to realize their dreams.

By the time students arrive for an interview, they have completed a personal essay on why they have chosen to enter a health care field, submitted transcripts, and secured two personal recommendations. Academic achievement as well as work and volunteer experience paint a picture of their hopes, abilities, and interests.

But it is the telling of their stories in their own words that proves so inspiring. Almost always, they have chosen to work in health care out of a deep commitment to helping people. Most touching, it is often inspired by the devoted and professional care they or a loved one have received.

The awards are competitive, and students have an opportunity to renew each year if they maintain strong grades. Upon graduation they are asked to seek employment in Wilkes County, thus helping ensure that our community has an educated, dedicated work force to care for our aging population. Those who are unable to do so are asked to repay their awards.

Scholarships are funded both through the endowed earnings of named scholarships as well as gifts from within the community.

We are pleased to present the 2011 scholarship recipients:

Theresa Jarvis received the **Betty Winslow Scholarship**. The fund was established to honor Betty Winslow, who has a strong commitment to both the health care field and a belief in life-long learning. She retired after a distinguished career as director of the Wilkes Regional Medical Center Radiology Technology program.

Kimberly Taylor was awarded the **Shirley and Alvin Sturdivant Scholarship**. Mr. Sturdivant is the founder and first president of The Health Foundation. Mrs. Sturdivant is a retired nurse. Ms. Taylor also received the **R.L. and**

Doris Melton Family Scholarship, which was established to benefit nursing students who intend to work in Wilkes.

Chris Shumate was awarded the **Ben Abernethy Scholarship Award**, which is given to a student attending the Wilkes Community College's Nursing program. This fund was established by students at WCC who wished to pay condolences to long-time nursing instructor Laura Abernethy, who was Mr. Abernethy's wife at the time of his death. Mr. Shumate also received the **Dr. Ray Inscore Nursing Scholarship**. Dr. Inscore devoted his life to the medical profession and his patients; the scholarship was established by his family to commemorate and continue his work.

Jason Riddle and **Rebecca White** received awards to study Radiology Technology at WRMC.

Kasey Prevette and **Brandie Stone** won scholarships to study dental assisting at Wilkes Community College.

Yuliya Pankoski, recipient of 2010's **Betty Winslow Scholarship**, and **Antonio Rubio Reyes**, recipient of 2010's **Shirley and Alvin Sturdivant Scholarship**, received renewal of their scholarships based on their academic performance.

To date, The Health Foundation has awarded \$113,800.00 in scholarships to 74 students.
